# State Water Board Issues Notices of Violation to Urban Water Suppliers Failing to Meet Conservation Standard

The State Water Board has begun issuing notices to urban water suppliers that have failed to meet the conservation standard of 25 percent.



Urban water suppliers that did not meet the standard in June received notices in early August warning them that they need to take immediate steps to enhance water conservation efforts to ensure that the conservation requirement is achieved.

Recipients were issued an Information Order with a requirement to provide the State Water Board information relating to their water production, water use, and water conservation efforts. Failure to provide the information by August 19, or any additional time extension granted, would be considered a violation subject to civil liability of up to \$500 per day, for each day the violation continues.

## Statewide Tax on Water Bills/Public Goods Charge May be Considered by Legislature in 2016

CalMutuals has learned that the Legislature may consider a public goods charge on water bills in the 2016 legislative session.

In anticipation, our staff submitted a letter to leaders in Sacramento letting them know of our opposition to any such bill.



CalMutuals emphasized to legislators the fact that our members have made, and continue to make, significant local investments in conservation programs and infrastructure, including, but not limited to, miles of pipeline replacements, installation of smart meters, water treatment projects and well rehabilitations, that have allowed their respective agencies to respond to the current drought.

Our staff will keep our members updated on this issue.

## **Chromium 6 Bill Awaiting Governor's Signature**

Last July, California became the first state in the nation to set a maximum contaminant level (MCL) of 10 parts per billion (ppb) for chromium-6 in drinking water. This new state standard comes with a compliance cost ranging anywhere from \$30 to \$75,000 per connection (AWWA).



Earlier this year, CalMutuals submitted a letter in support of SB 385 which would aid water systems in complying with the new standard by granting an additional five (5) years to comply, allowing water systems time to identify cost-effective treatment and financing methods. A public water system must request/and receive an approval for a variance from the State Board following the submission of a compliance plan.

#### How this impacts your mutual water company:

Unlike the federal government, the State does not allow time for water systems to come into compliance with a new drinking water standard.

The State Water Board already has the authority to grant variances; however, legislation is required to issue a variance for newly adopted standards. SB 385 would grant the State Board the ability to issue a variance for systems seeking additional time to come into compliance with the new standard for Hexavalent Chromium.

The bill has passed both the State Assembly and Senate and has been sent to Governor Brown's desk for his signature.

## Free AB 54 Training for Mutual Water Company Board Members

There will be a free AB 54 training for mutual water company board members on September 29th.



Starting in 2012, all mutual water company board members are required to participate in a two hour training every six years, and within six months of joining the board.

Required topics of training include: conflicts of interest, fiduciary responsibilities, Safe Drinking Water Act compliance, long term management and Capital Improvement Planning. The workshop meets the legal requirement for board members ethics training under AB 54.

### **AB 656 Awaiting the Governor's Signature**

Both the State Assembly and Senate have passed AB 656 and it is now on Governor Brown's desk awaiting his signature.

If signed by the Governor, AB 656 will allow mutual water companies to work with public agencies to form a joint insurance authority (JPA). Under AB 656, the JPA would be



empowered to create a joint insurance authority, helping mutual water companies reduce risk, stabilize insurance premiums, and pursue grants that will help mutual water companies improve our systems.

The deadline for submitting letters of support to the Governor's office is this Friday, September 4th.

The Department of Water Resources (DWR) has released the draft Guidelines for the Sustainable Groundwater Planning (SGWP) Grant Program and draft Proposal Solicitation Package (PSP) for the "Counties with Stressed Basins."



This release of the draft guidelines and the PSP officially opens the public comment period. The public comment period will close on October 5, 2015 at 5:00 PM.
