### California Association of Mutual Water Companies (CalMutuals) Board of Directors Meeting Minutes May 16, 2017

Call to Order: Chair Yamashita-Lopez called the meeting to order at 1:33 p.m.

**Present:** Lisa Yamashita-Lopez (Director, President & Chair), Dave Armstrong (Director, Vice President), Dave Michalko (Director, Secretary – joined the meeting at 2:02 p.m.), Doug Nunneley (Director), Jim Byerrum (Director), Ken Bradbury (Director), Ken Tcheng (Director), Adan Ortega (Staff, Executive Director), Denise Peralta Gailey (Staff, Managing Director), Myra Evangelista (Staff, Treasurer), Jim Ciampa (Legal Counsel), Lynda Noriega, Paul Fuller.

Absent: None.

**<u>Review and Approval of the April 18, 2017 Board Meeting Minutes</u>: On a motion made by Director Nunneley, seconded by Vice President Armstrong, the April 18, 2017 board meeting minutes were unanimously approved, as submitted.** 

<u>Chair's Report:</u> Chair Yamashita-Lopez reported that staff had developed new member packets which she asked that staff forward to the board once final edits were incorporated. Chair Yamashita-Lopez added that she continues to assist Averydale Mutual Water Company with various concerns. Chair Yamashita-Lopez asked staff for an update regarding the technical assistance applications that were submitted to the State Water Resources Control Board and Executive Director Ortega stated that all of the applicants had received a response from the State Water Resources Control Board regarding the status of their application. Managing Director Peralta Gailey reported that staff had submitted a technical assistance application on behalf of Mi-Wuk Heights Mutual Water Company.

**Executive Director's Report:** Executive Director Ortega reported that he and President Yamashita-Lopez would be meeting with Rick Cook of Bellflower Somerset Mutual Water Company to discuss joining the board of directors. Executive Director Ortega added that he had also spoken with Julie Hutchinson of Banning Heights Mutual Water Company about joining the board. Managing Director Peralta Gailey added that she had spoken to Van Grayer of Vaughn Water Company about joining the board.

<u>**Committee Chairs' Report</u>**: Vice President Armstrong provided an overview of the bills that the legislative committee has taken positions on adding that the next legislative committee meeting would be taking place by phone on Wednesday, May 17<sup>th</sup>. Director Tcheng provided a detailed report of the issues discussed during the regulatory affairs committee call which included updates regarding: (1) Chrom6; (2) 1,2,3-TCP, and (3) Perchlorate.</u>

**Budget Report**: Staff Member Evangelista provided an overview of the demand sheet. On a motion made by Vice President Armstrong seconded by Director Nunneley, the demand sheet was unanimously approved. Staff Member Evangelista disseminated and reviewed the financial statements noting that there is currently \$22,220.80 in the bank. Director Armstrong added that his office had mailed a check for charter membership in the amount of \$12,000.

**Director Comments**: President Yamashita-Lopez asked Mr. Fuller to contact Zenith Insurance Company regarding invoicing as her office received two incorrect invoices from the insurance company.

### California Association of Mutual Water Companies (CalMutuals) Minutes of the Annual Membership Meeting June 2, 2017

<u>Call to Order:</u> Secretary of the Board Dave Michalko called the meeting to order at 11:06 a.m. He announced that he was presiding over the meeting given the absence of Lisa Yamashita-Lopez (Director, President & Chair), and Dave Armstrong (Director, Vice President). Secretary Michalko noted that Doug Nunneley (Director), Jim Byerrum (Director), Ken Bradbury (Director), Ken Tcheng (Director), as well as Adan Ortega (Staff, Executive Director), Denise Peralta Gailey (Staff, Managing Director), Myra Evangelista (Staff, Treasurer), Jim Ciampa (Legal Counsel), and Lynda Noriega were present.

**Establishment of a Quorum:** Legal Counsel Jim Ciampa announced that 65 members were present in person or by proxy, establishing a quorum of over one-third (33.3%) of the 187 members to conduct the business of the organization.

**Election of Directors:** Legal Counsel Jim Ciampa announced that to fill two of three positions on the board of directors open for election (one by vacancy), Dave Michalko and Doug Nunneley had been duly nominated for election. Legal Counsel Ciampa opened the floor for additional nominations and none were made. Closing the nominations process, Legal Counsel Ciampa announced the election of Dave Michalko with 52 votes, and Doug Nunneley with 51 votes to the Board of Directors for three-year terms.

<u>Presentation of Awards</u>: Director Jim Byerrum presented the "Blanche Vizzini Award" to CalMutuals Treasurer, Myra Evangelista, for her outstanding service in the establishment and management of CalMutuals and CalMutuals JPRIMA.

Secretary Michalko and Executive Director Adan Ortega presented awards for outstanding volunteer service to Van Grayer of Vaughn Water Company for his leadership in the establishment of a standard for 1,2,3, TCP, helping affected water suppliers to recover costs from parties responsible for contamination; and to Owen Sharp of San Andreas Mutual Water Company, for his efforts to assist in the litigation to invalidate an unjust standard for hexavalent chromium that was adopted by the State of California without complying with the law requiring an affordability study be conducted.

**<u>Raftelis Rate-Setting Workshop:</u>** Sanjay Gaur and Kevin Kastivk of Raftelis Financial Consultants conducted an informative and engaging workshop about the factors affecting water rates and the process of adopting a water rate structure.

**Holman Capital Finance Presentation:** Frank Gill of Holman Capital Corporation provided a presentation about traditional and new innovative strategies mutual water companies can employ to finance capital improvement projects.

**Executive Director's Report:** Executive Director Ortega reported that two groups would be meeting during a working lunch upon adjournment of the annual meeting to consider strategies for dealing with the legal and regulatory process for hexavalent chromium, and potential legislative strategies to deal with deficiencies in the California Sustainable Ground Water Management Act's groundwater sustainability agency formation and planning processes.
